## INSTRUCTIONS TO BIDDERS

Sale of One (1) Unit of Mercedes Benz ML350 on an "as is, where is basis"

# A. Inspection of the Used Motor Vehicle

The used vehicle for sale, one (1) unit of Mercedes Benz ML350 (2009), is available for inspection/viewing from 06 to 08 March 2023, on an appointment basis at the Philippine Embassy, 001 Mzima Springs Road, Lavington, Nairobi. # B. Submission of Bids and Schedule of Public Bidding

- 1. The submission of bids for the vehicle is from 09 March 2023 up to 12:00 pm of 10 March 2023.
- Bidders are requested to submit their Bid Tender (please see attached sample), in a sealed envelope, to the Philippine Embassy in Nairobi (Nairobi PE) - Disposal Committee at the address below:

3. Sealed envelopes must be appropriately labeled with the following details:

- 4. Bids submitted below the minimum amount mentioned above shall be disqualified.
- A Tender Box shall be made available at the receiving area of the Philippine Embassy for bidders to drop off their sealed bids.
- Bids submitted after the deadline of 12:00 pm of 10 March 2023 shall no longer be considered.

# C. Qualifications of Bidders

Individuals, partnerships and/or corporations are qualified to participate in the public auction, subject to the submission of qualified documents as may be required by Nairobi PE - Disposal Committee. Employees of the Philippine Embassy are not qualified to submit bids.

#### D. Minimum Bid

The minimum bid for the motor vehicle for sale is set at Eight Hundred Thousand Kenyan Shillings (KSH 800,000.00).

#### E. Modification and Withdrawal of Bid

- A bidder may modify his/her bid after submission, provided a written notice is sent to the Nairobi PE - Disposal Committee and that the modified bid is received prior to the set deadline.
- 2. A bidder may, through a Letter of Withdrawal, withdraw his/her bid after it has been submitted for valid and justifiable reasons. The Letter of Withdrawal must be received by the Nairobi PE - Disposal Committee prior to the deadline of submission of bids. A bidder who withdrew his/her bid shall not be entitled to submit another bid for the same project.
- 3. Modification and/or withdrawal of bids shall not be allowed after the deadline of submission of bids.

# F. Opening of Bids

- The opening of bids, to be administered by the Nairobi PE Disposal Committee, is set on 10 March 2023, 02:00 pm at the Conference Room of the Philippine Embassy in Nairobi.
- An Abstract of Bids shall be prepared by Nairobi PE Disposal Committee.

# G. Awarding of Bids

- 1. Award shall be granted to the highest bidder.
- In case of a tie, Nairobi PE Disposal Committee shall resort to non-discretionary criteria (toss coin or draw lots) to determine the winning bidder.
- 3. If the winning bidder refuses to accept the award, the next highest bidder shall be awarded the bid, and so on and so forth. However, any bidder who refuses to accept the award shall be blacklisted and shall not be allowed to participate in future biddings, without prejudice to Nairobi PE - Disposal Committee's other courses of action and remedies to it.

## H. Payment

- One-time payment in cash shall be made by the winning bidder within five (5) business days from the date of receipt of the Notice of Award.
- An official receipt shall be issued by Nairobi PE covering the payment made by the winning bidder.

## I. Taxes and Other Charges

All taxes and other charges in relation to the purchase of the used motor vehicle and transfer of registration, including, hauling of the vehicle from the Embassy of the Philippines are for the account of the winning bidder.
